QUALITATIVE ASSESSMENT OF LIQUIDITY CONDITION (QUARTERLY)

Analysis

Based on POJK no.42/POJK.03/2015 concerning Liquidity Coverage Ratio Requirements for Commercial Banks, we would like to inform as follows:

- 1. The Bank's LCR for Q2-2023 is 177.44%, still above OJK's minimum requirement of 100%. This indicates that the Bank's liquidity adequacy is satisfactory and is able to meet the Bank's liquidity needs for the next 30 (thirty) days in a stress scenario.
- 2. The Bank's LCR decreased by 55bps from Q1-2023 position of 232.56%. This was mainly due to the Bank's net cash outflow which was increased by 21.7%, coupled with decrease of total HQLA by 7.1%.
- 3. The total HQLA owned by the Bank in Q2-2023 is HQLA Level 1 with an average ownership of government securities of IDR 5.18 trillion. Currently the Bank does not have the portfolio of HQLA Level 2A and 2B.
- 4. The estimated Net Cash Outflow for Q2-2023 was IDR 3.63 trillion, which was resulted from the estimated cash outflow of IDR 7.68 trillion deducted by the estimated cash inflow of IDR 4.05 trillion.
- 5. The estimated cash outflow for the next 30 days from individual and corporate customers after taking into account the run-off rate was IDR 141 billion and IDR 2.35 trillion, respectively. In Q2-2023, the Bank's deposits from corporate customers decreased by 12%, while deposits from individual customers increased by 4%. The Bank is committed to continuously improving more stable funding such as the deposits from individuals and micro/small businesses.
- 6. The Bank has implemented the liquidity risk management process and actively identifies, measures, monitors, and controls the liquidity risk exposure through daily report and monthly report. The Bank identifies and measures the liquidity risk exposures of each product and activity using several parameters or indicators such as MCO, stress testing, liquidity ratios such as Loan to Deposit (LDR) ratio, Short Term Foreign Borrowing (STFB), Top 50 Depositors ratio, etc.
- 7. Liquidity Risk management strategy, such as funding strategy, positioning and liquidity risk management, collateralized high quality liquid assets management, and etc, are regularly reviewed in ALCO, RMC, RMOC and/or BOC meetings.
